**RESPECTFULLY REPRESENT YOUR PETITIONERS**, being five residents of the Town of Stoughton, that common convenience and necessity require that a portion of the Norfolk County Layout of Page Street dated October 22, 1872, a public way laying in Stoughton, be altered for the purpose of discontinuing a portion of said layout in the area described as follows:

**Discontinuance Area**

The area being shown as "Roadway Area" containing 33,642 square feet on a plan entitled "Plan showing the discontinuance of a portion of the October 22, 1872 Norfolk County Layout of **OLD PAGE STREET in Stoughton, MA**", scale 1 inch = 60 feet, dated September 13, 2023, prepared by Langan Engineering & Environmental Services, Inc., as more particularly described as follows:

Beginning at the most southerly point of the area herein described. Said point being on the southerly sideline of the October 22, 1872 Norfolk County Layout of Old Page Street located in the Town of Stoughton, thence

N50 07 32W 23.00 feet to a point, thence turning and running;

N42 07 32W 89.66 feet to a point, thence turning and running;

N33 03 35W 566.80 feet to a point, thence turning and running;

N55 00 23E 50.03 feet to a point, thence turning and running;

S33 03 35E 564.53 feet to a point, thence turning and running;

S42 07 32E 82.20 feet to a point, thence turning and running;


S50 07 32E 19.50 feet to a point, thence turning and running;

S39 52 28W 50.00 feet to the point of beginning.


**WHEREFORE YOUR PETITIONERS PRAY** that said way may be altered by discontinuance within the limits as specified above.
