with ties, and subsequent monumentation and updated ties to the monument locations can be researched.

If you encounter issues performing research on the website or recovering monuments for Norfolk County layouts in the field, it is recommended that you call the office. Please call to discuss the online research assistance you need. To aid with monument recovery in the field it is recommended that a review of the Layout Office Copies is performed as these plans depict the monuments set in the field. Also, field book notes and field book note ties that depict the layout takings, the monuments set, traverse, control and ties are available and can be very useful aid with right of way monument recovery.

In the field we suggest extending the survey beyond locus to recover layout monuments in areas that have not been disturbed or destroyed. If upon full research of available records and reconnaissance in the field you are unable to recover a sufficient number of monuments on the ground as required by 250 CMR, please contact the office to review.

The Norfolk County Engineering Department is continuously working on projects for the County of Norfolk and for the twenty-eight Communities located within Norfolk County. The Norfolk County Engineering Department is therefore available to assist with County layout monument recovery as times permits/allows. Unfortunately, the department cannot accommodate requests for immediate services related to monument recovery.

William P. O'Donnell of Norwood is Register of Deeds for Norfolk County, and by virtue of that office, serves as an Assistant Recorder of the Massachusetts Land Court. The information related to Registry of Deeds research and standards are taken from information provided by the Register of Deeds online records website.

The Massachusetts Registers and Assistant Registers of Deeds Association Indexing Standards encourage uniformity in recording and land records practices in Massachusetts. It is important to recognize, however, that because of historical development of local and regional practices over many years, there are specific instances in which local registry policy and practice may be different from the general rules set forth in the Indexing Standards. As a minimum, recordable plans must be prepared in conformance with the Rules & Regulations of the Registry of Deeds. Applicable recording standards and regulations set forth by the Registers of Deeds related to Plan Regulations, promulgated effective January 12, 1988, pursuant to the provisions of M.G.L. Ch.36 § 13A. Additional requirements for plan format and content may be set forth independently by each City & Town through various Boards, Commissions, and Committees.
