Hill and others, of Norfolk in said County, represents as follows: Commonwealth of Massachusetts Norfolk, ss. To the Honorable the County Commissioners of the County of Norfolk: Respectfully represent your petitioners, inhabitants of the town of Norfolk in said County, that common convenience and necessity require that the way known as Pine Street, a public way in said town, be relocated between the N.Y., N.H. & H.R.R. and the Foxborough Town Line for the purpose of establishing the boundary lines of said way, making alterations in the course or width of said way, and making repairs on said way. Wherefore your petitioners pray that said way may be relocated within the limits above specified. Dated March 24, 1930.

This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners, held at Dedham, aforesaid, on the first day of April 1930, by adjournment of their December meeting next preceding; and the thirteenth day of May then next, and 10:45 o'clock in the forenoon, at the Court House in said Dedham, were appointed by the Commissioners as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said petition, and of this order thereon, to be served upon the Clerk of the Town of Norfolk, being the town within which such relocation of way was prayed for, thirty days at least before the time appointed for said view; and also caused copies of said petition and order to be posted in two public places in said town; and also gave notice to all persons interested, by causing a like copy to be published three weeks successively in the Franklin Sentinel, a newspaper printed in said County, said posting and the last publication of said copy having been fourteen days at least before the time appointed for said view, that all persons and corporations interested for or against said petition, might then and there appear and be heard if they saw fit. And on the said thirteenth day of May, the Commissioners, Edward W. Hunt, Frederick A. Leavitt, and Russell T. Bates, met at the time and place specified in said order, and no party interested appearing, said hearing was thence continued and adjourned to a meeting of the Commissioners held at Dedham aforesaid on the twentieth day of May, by adjournment of their April meeting next preceding. And on the said twentieth day of May, the Commissioners met, when and where the petitioners appeared, and the town of Norfolk was represented by its selectmen; and the said Commissioners then viewed the route and premises, and heard all persons and corporations interested; and no party interested objected; and thereupon the said Commissioners did adjudge that common convenience and

necessity require that said way be relocated as prayed for in said petition. And thence the same was continued and adjourned from time to time to this meeting. And now the said Commissioners, by courses and distances;metes and bounds,do relocate said Pine Street,Norfolk, as prayed for in said petition. And the lines of said relocation of said Pine Street are as follows: The northerly line begins at a stone bound in the easterly line of location of the N.Y.,N.H. & H.R.R.,said bound bearing S 32-06 E 88.21 ft. from the last bound in the northerly line of a new way in the Town of Norfolk as laid out by the Norfolk County Commissioners on even date herewith. Thence S 32-06 E 135.95 ft. to a stone bound;thence by a 60 ft. radius curve to the left 122.82 ft. to a stone bound in the westerly line of Everett St.;thence S 20-13-50 E 64.48 ft. across said Everett St. to a stone bound;thence southerly and easterly by a 90 ft. radius curve 116.28 ft. to a stone bound;thence S 43-25 E 413.87 ft. to a stone bound;thence by a 2000 ft. radius curve to the left 268.24 ft. to a stone bound;thence continuing by the same curve 268.25 ft. to a stone bound;thence S 58-47-10 E 500 ft. to a stone bound;thence by the same course 600 ft. to a stone bound; thence by the same course 616.70 ft. to a stone bound in the Foxborough Norfolk Town Line. The southerly line begins at a stone bound in the easterly line of location of the N.Y., N.H. & H.R.R.,said bound bearing S 37-43-30 W 63.92 ft. from the point of beginning of the northerly line as above described;thence southeasterly and southerly by a 500 ft. radius curve 169.18 ft. to a stone bound;thence continuing by a 300 ft. radius curve to the right 226.85 ft. to a stone bound on the westerly side of Everett St.;thence N 54-51-40 E 121.73 ft. across said Everett St. to a stone bound;thence northeasterly,easterly and southeasterly by a 60 ft. radius curve 110.97 ft. to a stone bound;thence S 43-25 E 384.97 ft. to a stone bound;thence by a 2060 ft. radius curve to the left 276.3 ft. to a stone bound;thence continuing by the same curve 276.3 ft. to a stone bound;thence S 58-47-10 E 500 ft. to a stone bound;thence by the same course 600 ft. to a stone bound;thence by the same course 591.14 ft. to a stone bound in the Norfolk-Wrentham town line;thence S 72-26-E 36.15 ft. in said Norfolk-Wrentham Town line to the Norfolk,Wrentham,Foxborough Town corner bound, said bound bearing S 20-42 W 52.35 ft. from the last bound in the northerly line as above described. Said lines are shown upon a plan entitled "Plan showing the Relocation and Widening of Pine St.,Norfolk from the N.Y.,N.H. & H.R.R. to the Foxborough Town Line as made by the Norfolk County Commissioners by return dated October 7,1930. Hartley L.White,County Engineer. Scale 1 inch = 40 feet" and marked "Edward W.Hunt,Chairman" which plan is filed herewith and made a part of this return. And the said commissioners do hereby take for the purposes of a highway all the easements and rights incident to a public highway in the lands included within the lines of relocation hereinbefore described and as shown on the plan hereinbefore referred to and made a part hereof in so far as such lands may lie outside the limits of said way as heretofore defined. And permanent stone or concrete bounds,not less than three feet long,two feet of which at least shall be inserted in the earth,will be erected at the termini and angles of the way relocated as aforesaid,when practicable;and when not os,a heap of stones,a living tree,a permanent rock,or the corner of an edifice will

be a substitute; or said bounds may be permanent stone or concrete bounds not less than three feet long, with holes drilled therein, and filled with lead, placed a few inches below the travelled part of the street or way, and it is determined by the Commissioners that the inhabitants of the Town of Norfolk do within two years from the date of this return and order complete said way in a thorough and workmanlike manner and to the acceptance of the County Commissioners. Said way shall be constructed to the full width indicated on said plan throughout the entire length of the portion relocated by this return and order. Suitable sidewalks, gutters, culverts, retaining walls, fences and railings shall be constructed wherever needed. And it is determined by the Commissioners that all the expenses of making the relocation of way prescribed in this return and order including the expenses of constructing said way, and the removal of all buildings, structures, hedges, walls, and fences from the lands taken, and all land and other damages and expenses incident thereto, be paid by the inhabitants of the Town of Norfolk, and the Commissioners have heard the proprietors of lands and property, rights and interests, taken or affected by these proceedings, and have considered and estimated the damages sustained in the premises, having had regard to all the damages done to the parties respectively, whether by taking their property or injuring it in any manner, and having allowed, by way of set off, the benefits, if any, to the property of said parties in the premises, and do estimate and determine the damages to be paid to said parties respectively, in the sums hereafter named; the same to be paid to said parties respectively, in the sums hereafter named; the same to be paid to said parties respectively by the inhabitants of the Town of Norfolk when the lands hereby taken and over which said way is hereby located, have been entered upon and possession taken, for the purpose of constructing the said way: .
