Respectfully represent your petitioners, inhabitants of the town of NORWOOD in said County, that common convenience and necessity require that the way known as Old Washington Street, a public way in said town, be relocated between its intersection with Washington Street and the New York, New Haven and Hartford right of way for the purpose of making alterations in the course or width of said way.

Wherefore your petitioners pray that said way may be relocated within the limits above specified.

This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners, held at Dedham, aforesaid, on the fifth day of July, 1939, by adjournment of their June meeting next preceding: and the twenty-fifth day of July then next and two o'clock in the afternoon, at the Court House in said Dedham were appointed by the Commissioners as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said petition, and of order of notice thereon, to be served upon the Clerk of the Town of Norwood, being the town within which such relocation of way was prayed for, fifteen days at least before the time appointed for said view: and

also caused copies of an abstract of said petition and of said order of notice to be posted in two public places in said town: and to be published in the Daily Messenger, a newspaper published in said County, said posting and publication having been seven days at least before the time appointed for said view, that all persons and corporations interested for or against said petition, might then and there appear and be heard if they saw fit.

And on the said twenty-fifth day of July, the Commissioners Frederick A. Leavitt, Edward W. Hunt, and Russell T. Bates met at the time and place specified in said order, when and where the petitioners appeared, and the town of Norwood was represented by its Selectmen; and the said Commissioners then viewed the route and premises, and heard all persons interested; and no party interested objected: and thereupon the said Commissioners did adjudge that common convenience and necessity require that said way be relocated as prayed for in said petition.

And thence the same was continued and adjourned from time to time to a meeting of said Commissioners held at Dedham on the fourteenth day of November, 1939 when and where the Commissioners futher heard the petitioners and owners of property to be taken or affected by said proceedings and thence the same was continued and adjourned from time to time to this meeting.

And now the said Commissioners, by courses and distances, metes and bounds, do relocate said Old Washington Street as prayed for in said petition.

And thelines of said relocation of said Old Washington Street are as follows:-

The westerly line of said way begins at the center of the back of an old county highway bound, said bound bearing S-20-52-30-E 27.10 feet from the southeast corner of the dwelling house belonging to John A. Abdallah, thence N-20-39-30-E 325.60 ft. in the westerly line of said way as determined by the County Commissioners by a Return dated March 28, 1876 to a stone bound in the

southerly line of location of the N. Y., N. H., & H. R. R; thence N-58-11-E 72.66 ft. in said southerly line of location to an unmarked point; thence south 67-55-40-E 1.45 feet to a stone bound.

The easterly line of said way begins at the point of beginning of the westerly line as above described; thence S-82-21-30-E 57.37 ft. across the southerly end of said way to a bolt in granolithic sidewalk, said bolt being in the westerly line of Washington Street as laid out in January 1895 under the Grade Crossing Act; thence N-59-31-10-W 11.00 ft. to a bolt in granolithic sidewalk; thence N-18-50-50-W 7.97 ft. to a bolt in granolithic sidewalk; thence N-20-39-30-E 131.00 ft. to a stone bound; thence N-22-04-20-E 231.33 ft. to a stone bound, said bound being the last bound in the westerly line as above described.

Said lines are shown upon a plan entitled "Plan showing the Relocation of Old Washington St., Norwood from Washington St. to the N. Y., N. H., & H. R. R. as made by the Norfolk County Commissioners by Return dated Dec. 19, 1939. Hartley L. White, County Engineer. Scale 1 inch = 20 feet." and marked "Frederick A. Leavitt, Chairman." which plan is filed herewith and made a part of this Return.

And permanent stone or concrete bounds, not less than three feet long, two feet of which at least shall be inserted in the earth, will be erected at the termini and angles of the way relocated as aforesaid, when practicable; and, when not so, a heap of stones, a living trae, a permanent rock, or the corner of an edifice will be a substitute; or said bounds may be permanent stone or concrete bounds not less than three feet long, with holes drilled therein, and filled with lead, placed a few inches below the travelled part of the street or way.
