And it is determined by the Commissioners that all the expenses of making the relocation of way as prescribed in this return and order including the expense of constructing said way, and all land and other damages and expenses incident thereto be paid by the Inhabitants of the Town of Norfolk; and that the County of Norfolk shall pay to the Inhabitants of the Town of Norfolk the sum of Ninety Dollars (\$90.00) payment thereof to be made at such time as the commissioners may determine, having regard to the amount of the work done and the proportion of the expense to be paid by the County. Commissioners have heard the proprietors of lands and property, rights and interests taken or affected by these proceedings and have considered and estimated the damages sustained in the premises having had regard to all the damages done to the parties respectively whether by taking their property or injuring it in any manne, and having allowed by way of set off, the benefits if any, to the property of said parties in the premises and do estimate and determine the damages to be paid to said parties respectively in the sums hereafter named; the same to be paid to said parties respectively by the Inhabitants of the Town of Norfolk when the lands hereby taken and over which said way is hereby located have been entered upon and possession taken for the purpose of constructing the said way.
