that the way known as Pleasant Street, a public way in said town, be relocated between the Norweed-Walpole town line and Coney Street for the purpose of establishing the boundary lines of said way, making alterations in the course or width of said way, and making repairs on said way. This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners held at Dedham aforesaid on the eighth day of November 1927 by adjournment of their September meeting next preceding; and the twentieth day of December then next, and 11:00 o'clock in the forenoon, at the Court House in said Dedham, were appointed by the Commissioners as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said petition and of this order thereon, to be served upon the Clerk of the Town of Walpole, being the town within which such relocation of way was prayed for, thirty days at least before the time appointed for said view; and also caused copies of said petition and order to be posted in two public places in said town; and also gave notice to all persons interested, by causing a like copy to be published three weeks successively in the walpole Times, a newspaper published in said County, said posting and the last publication of said copy having been fourteen days at least before the time appointed for said view, that all persons and corporations interested for or against said petition, might then and there appear and be heard if they saw fit. And on the said twentieth day of December, the Commissioners, Evan F. Richardson, Edward W. Hunt, and Frederick A. Leavitt, met at the time and place specified in said order, when and where the petitioners appeared, and the town of Walpole was represented by its selectmen; and the said Commissioners then viewed the route and premises and heard all persons and corporations interested; and no party interested objected; and thereupon the said Commissioners did adjudge that common convenience and necessity require that said way be relocated as prayed for in said petition. And thence the same was continued and adjourned from time to time to this meeting. And now the said Commissioners, by courses and distances, metes and bounds, do relocate said Pleasant Street as prayed for in said petition. And the lines of said relocation of said Pleasant Street are as follows: The westerly line of Pleasant Street begins at a stone

bound in the northerly line of Wolcott Avenue, said bound being 63.8 ft.southerly from the northwest corner and 56.25 ft. southwesterly from the southeast corner of house at the northerly corner of Wolcott Ave. and Pleasant St. belonging to the Walpole Home Building Company; thence southeasterly and northeasterly by a 40 ft.radius curve 88.20 ft.to a stone bound; thence N 15-47-40 E 150.23 ft. to a stone bound; thence by a 2660 ft. radius curve to the right 237.36 ft.to a stone bound; thence continuing by the same curve 237.35 ft.to a stone bound; thence N 26-01-10 E. 142.66 ft. to a stone bound; thence by a 30 ft. radius curve to the left 52.30 ft. to a stone bound in the southerly line of Union St. Then beginning at a stone bound in the northerly line of said Union Street at a point bearing N 29-46-10 E 44.68 ft.from the last described bound; thence easterly and northerly by a 40 ft. radius curve 55.33 ft. to a stone bound: thence N 20-17-40 E 357.70 ft. to a stone bound; thence by a 1960 ft. radius curve to the right 338.66 ft.to a stone bound; thence N 30-11-40 E.336.54 ft. to a stone bound in the Walpole-Norwood town line. The easterly line begins at a stone bound in the present easterly line of Pleasant Street, said bound bearing S 26-30-50 E 308.00 ft.from the point of beginning of the westerly line as above described; thence N 4-15-20 W 62.38 ft. to a stone bund; thence by a 1025.56 ft.radius curve to the right 358.88 ft.to a stone bound; thence continuing by a 2600 ft. radius curve to the right 253.18 ft. to a stone bound in the northerly line of a private way known as Burns Ave.; thence continuing by the same curve 210.82 ft. to a stone bound; thence N 26-01-10 E 157.15 ft. to a stone bound; thence by a 25 ft. radius curve to the right 37.51 ft. to a stone bound in the southerly line of Union Street. Then beginning at a stone bound in the northerly line of Union Street, said bound bearing N 47-08-10 E 44.18 ft.from the last described bound; thence westerly and northerly by a 40 ft.radius curve 61.65 ft.to a stone bound; thence N 20-17-40 E 363.66 ft.to a stone bound; thence by a 1900 ft. radius curve to the right 328.30 ft. to a stone bound at land of the East Walpole Cemetery Association; thence S 79-34 W 6.59 ft. by land of said Cemetery Association to a stone bound in the present easterly line of Pleasant Street; thence N 30-11-40 E 318.82 ft.in the said present easterly line of Pleasant Street to a town bound in the Walpole-Norwood town line; thence N 37-55-20 W 59.25 ft.in said town line to the last bound in the westerly line as above described. Said lines are shown upon a plan entitled "Plan showing the Relocation and Widening of Pleasant St., Walpole from Wolcott Ave. to the Nerwood Town Line as made by the Norfolk County Commissioners by Return dated May 29,1928. Hartley L. White, County Engineer. Scale 1 inch-40 feet" and signed "Evan F. Richardson, Chairman" which plan is filed herewith and made a part of this return. And the said commissioners do hereby take for the purposes of a highway all the easements and rights incident to a public highway in the lands included within the lines of relocation

hereinbefore described and as shown on the plan hereinbefore referred to and i made a part hereof in so far as such lands may lie outside the limits of said way as heretofore defined. And permanent stone or concrete bounds, not less than three feet long, two feet of which at least shall be inserted in the earth, will be erected at the termini and angles of the way relocated as aforesaid, when practicable; and, when not so, a heap of stones, a living tree, a permanent rock, or the corner of an edifice will be a substitute; or said bounds may be permanent stone or concrete bounds not less than three feet long, with holes drilled therein, and filled with lead, placed a few inches below the travelled part of the street or way. And it is determined by the Commissioners that the Inhabitants of the Town of Walpole do within two years from the date of this return and order complete said way in a thorough and workmanlike manner and to the acceptance of the County Commissioners. Said way shall be constructed to the full width indicated on said plan throughout the entire length of the portion relocated by this return and order. Suitable sidewalks, gutters, culverts, retaining walls, fences and railings shall be constructed wherever needed. And it is determined by the Commissioners that all the expenses of constructing the way prescribed in this return and order, excepting the payment of land damages as hereinafter stated, be paid by the Inhabitants of the Town of Walpole; and it is also determined by the Commissioners that upon payment by the County of the sums hereinafter awarded as damages, the Inhabitants of the Town of Walpole shall pay to the County of Norfolk the sum of Eight Hundred Seventy Dollars (\$870). And the Commissioners have heard the proprietors of lands and property, rights and interests, taken or affected by these proceedings and have considered and estimated the damages sustained in the premises, having had regard to all the damages done to the parties respectively, whether by taking their property or injuring it in any manner, and having allowed, by way of set off, the benefits, if any, to the property of said parties in the premises, and do estimate and determine the damages to be paid to said parties respectively, in the sums hereafter named; the same to be paid to said parties respectively out of the county treasury when the lands hereby taken and over which said way is hereby located have been entered upon and possession taken for the purpose of constructing said way.
