And the lines of said relocation of Centre Street are as follows: The westerly line begins at the Massachusette Highway Bound at the northerly end of the westerly line of said Centre Street as laid out by the Massachusetts Highway Commission on July 3,1902, said bound is near the northerly line of Westminster Ave. (so-called); thence N 53-14 W 5.00 ft.to a stone bound; thence N 35-30 E 531.5 ft.to a stone bound; thence by a 1210 ft. radius curve to the left 332.62 ft. to a stone bound; thence con tinuing by a 200.ft.radius curve to the left 133.48 ft.to a stone bound in the approximate westerly line of South Main Street. The easterly line begins at the Massachusetts Highway Bound at the northerly end of the easterly 1470 of said Centre Street as laid out by the Massachusetts Highway Commission July 3,1902, said bound bearing S 53-14 E 50.00 ft. from the point of beginning of the westerly line as above described; thence S 53-14 E 5.0 ft. to a stone bound; thence N 35-30 E 532.8 ft.to a stone bound; thence by a 1270 ft. radius curve to the left 146.05 ft. to a stone bound; thence N 28-54-40 E 120.1 ft. a stone bound; thence by a 54.82 ft. radius curve to the right 84.47 ft. to stone bound in the easterly line of Centre Street as laid out by the Norfol County Commissioners on December 28,1926 and in the approximate southerly line of Wrentham Street, said bound bearing S 26-10-50 E 232.60 ft.from the last bound in the westerly line as above described. And the said commissioners do hereby take for the purposes of a highway all the easements and rights incident to a public highway in the lands included within the lines of relocation hereinbefore described and as shown on the plan hereinbefore referred to and made a part hereof in so far as such lands may lie outside the limits of said way as heretofore defined. And permanent stone or concrete bounds, not less than three feet long, two feet of which at least shall be inserted in the earth, will be erected at the termini and angles of the way relocated as aforesaid, when practicable; and, when not so, a heap of stones, a living tree, a permanent rock, or the corner of an edifice will be a substitute; or said bounds may be permanent stone or concrete bounds not less than three feet long, with holes drilled therein and filled with lead, placed a few inches below the travelled part of the street or way. And it is determined by the Commissioners that the Inhabitants of the Town of Bellingham do within one year from the date of this return and order complete said way in a thorough and workmanlike manner and to the acceptance of the County Commissioners. Said way shall be constructed to the full width indicated on said plan throughout the entire length of the portion relocated by this return and order. Suitable sidewalks, gutters, culverts, retaining walls, fences and railings shall be constructed wherever needed. And it is determined by the Commissioners that all the expenses of constructing the way prescribed in this return and order, excepting the payment of land damages as hereinafter stated, be paid by the Inhabitants of the Town of Bellingham; and it is also determined by the Commissioners that upon payment by the County of the sums hereinafter awarded as damages, the Inhabitants of the Town of Bellingham shall pay to the County of Norfolk the sum of Two Hundred Ninety-Two Dollars (\$292.00). And the Commissioners have heard the proprietors of lands and property, rights and interests, taken or affected by these proceedings, and have considered and estimated the damages sustained in the premises, having had regard to all the damages done to the parties respectively, whether by taking their property or injuring it in any manner, and having allowed, by way of set off, the benefits, if any, to the property of said parties in the premises, and do estimate and determine the damages to be paid to said parties respectively, in the sums hereafter named; the same to be paid to said parties respectively out of the county treasury when the lands hereby taken and over which said way is hereby located, have been entered upon and possession taken for the purpose of constructing the said way.
