At a meeting of the County Commissioners for the County of Norfolk held at Dedham, within and for said County, on the twenty-third day of April 1929 by adjournment of their April meeting next preceding: The petition of Frank M. Noyes and others, of Avon in said County, represents as Commonwealth of Massachusetts Norfolk, ss. To the Honorable the follows: County Commissioners of the County of Norfolk; Respectfully represent your petitioners, inhabitants of the town of Avon in said County, that common convenience and necessity require that the way known as Pond Street, a public way in said town, be relocated from the present construction of said Pond Street to Central Street, and that the way known as Central Street, a public way in said town by relocated between Pond Street and Stoughton town line, for the purpose of establishing the boundary lines of said ways, making alterations in the course or width of said ways, and making repairs on said ways. Wherefore your petitioners pray that said way may be relocated within the limits above specified. Dated Dec.15,1928.

This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners, held at Dedham, afor esaid, on the eighteenth day of December 1928 by adjournment of their September meeting next preceding; and the twenty-ninth day of January then next, and 10:45 o'clock in the forenoon, at the Court House in said Dedham, were appointed by the Commissioners as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said patition, and of this order thereon, to be served upon the Clerk of the Town of Avon, being the town within which such relocation of way was prayed for, thirty days at least before the time appointed for said view; and also vaused copies of said petition and order to be posted in two public places in said town; and also gave notice to all persons interested by causing a like copy to be published three weeks successively in the Randolph Sentinel-News, a newspaper published in said County, said posting and the last publication of said copy having been fourteen days at least before the time appointed for said view, that all persons and corporations interested for or against aaid petition, might then and there appear and be

heard if they saw fit. And on the said twenty-ninth day of January, the Commissioners, Edward W. Hunt, Frederick A. Leavitt, and Russell T. Bates, met at the time and place specified in said order, when and where the petitioners appeared and the town of Avon was represented by its selectmen. And the same commissioners heard all persons and corporations interested; and no party interested objected, and thereupon the said Commissioners did adjudge that common convenience and necessity require that sid way be relocated as prayer for in said petition. And thence the same was continued and adjourned from time to time to this meeting. And now the said Commissioners, by courses and distances, metes and bounds, do relocate said Central Street as prayed for in said petition. And the lines of said relocation of said Central Street are as follows: The northerly line begins at a stone bound in the Avon-Stoughton town line, said bound being about 4 ft. northerly of the present northerly line of said Central Street; thence S.39-58-45 E.141.56 ft. to a stone bound; thence by a 4698 .56 ft. radius curve to the right 328.71 ft. to a stone bound; thence continuing by the same curve 328.70 ft. to a stone bound thence continuing by a 1350 ft. radius curve to the right 418.62 ft. to a stone bound; thence S 14-11-45 E 457.30 ft.to a stone bound; thence by a 19818 ft.radius curve to the left 116.12 ft. to a stone bound in the present northerly line of Pond St., said bound being at the middle point of the curve at the northerly corner of said Central and Pond Streets as laid out by the Norfolk County Commissioners by return dated November 10,1925, The southerly line begins at the point of beginning of the northerly line as above described; thence S.2-51-40 E.82.86 ft., in the said Avon Stoughton town line to a stone bound; thence S.39-58-45 E.75.50 ft.to a stone bound; thence by a 4648.56 ft. radius curve to the right 325.21 ft. to a stone bound; thence continuing by the same curve 325.20 ft. to a stone bound; thence continuing a 1300 ft. radius curve to the right 403.11 ft. to a stone bound; thence S 14-11-45 E 368.30 ft. to a stone bound, said bound bearing N 32-45-10 W 157.1 ft. and N 47-46 W 59.78 ft. from the last bound in the northerly line as about described. Said lines are shown upon a plan entitled "Plan showing the Relocation and Widening of Central Street, Avon, from the Stoughton Town Line Pond St. as made by the Norfolk County Commissioners by Return dated April 23,1929 Hartley L.White, County Engineer, Scale 1 inch 40 feet "and marked "Edward W.Hunt, Chairman" which plan is fiked herewith and made a part of this return. And the said commissioners do hereby take for the purposes of a highway all the easements and rights incident to a public highway in the lands included within the lines of relocation hereinbefore described and as shown on the plan hereinbefore referred to and made a part hereof in so far as such lands may lie outside the limits of said way as heretofore

long, two feet of which at least shall be inserted in the earth, will be erected at the termini and angles of the way relocated as aforesaid, when practicable and, when not so, a heap of stones, a living tree, a permanent rock, or the corner of an edifice will beasubstitute; or said bounds may be permanent stone or concrete bounds not less than three feet long, with holes drilled therein, and filled with lead, placed a few inches below the travelled part of the street or way. And it is determined by the Commissioners that the Inhabitants of the Town of Avon do within one year from the date of this return and order complete said way in a thorough and workmanlike manner and to the acceptance of the County Commissioners. Said way shall be constructed to the full width indicated on said plan throughout the entire length of the portion relocated by this return and order. Suitable sidewalks gutters, culverts, retaining walls, fences and railings shall be constructed wherever needed. And it is determined by the Commissioners that all the expenses of making the relocation of way prescribed in this return and order including the expenses of constructing said way, and the removal of all buildings, structures, hedges, walls and fences from the lands taken, and all land an other damages and expenses incident thereto, be paid by the Inhabitants of the Town of Avon; and that the County of Norfolk shall pay to the Inhabitants of the Town of Avon the sum of nine thousand dollars (\$9000) payment thereof to be made at such time as the commissioners may determine, having regard to the amount of the work done and the proportion of the expense to be paid by the County And the Commissioners have heard the proprietors of lands and property, rights and interests, taken or affected by these proceedings, and have considered and estimated the damages sustained in the premises, having had regard to all the damages done to the parties respectively, whether by taking their property or injuring it in any manner and having allowed, by way of set off, the benefits, if any, to the property of said parties in the premses and do estimate and determine the damages to be paid to said parties respectively, in the sums hereafter named; the same to be paid to said parties espectively by the Inhabitants of the Town of Avon when the lands hereby aken and over which said way is hereby located, have been entered upon and possession taken for the purpose of constructing said way.
