Gillespie and others, of Sharon in said County, represents as follows: Commonwealth of Massachusetts Norfolk, ss. To the Honorable

the County Commissioners of the County of Norfolk: Respectfully represent your petitioners, inhabitants of the town of Sharon, in said County, that common convenience and necessity require that the way known as South Main Street, a public way in said town, be relocated between the N.Y., N.H. & H.R.R. and Chestnut Street for the purpose of establishing the boundary lines of said way, making alterations in the course or width of said way, and making repairs on said way. Wherefore your petitioners pray that said way may be relocated within the limits above specified. Dated April 16, 1931.

This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners, held at Dedham, aforesaid, on the twenty-first day of April 1931, by adjournment of their December meeting next preceding; and the second day of June then next, and eleven forty five o'clock in the forenoon, at the Court House in said Dedham were appointed by the Commissioners as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said petition, and of this order thereon, to be served upon the Clerk of the Town of Sharon being the town within which such relocation of way was prayed for, thirty days at least before the time appointed for said view; and also caused copies of said petition and order to be posted in two public places in said town; and also gave notice to all persons interested, by causing a like copy to be published three weeks successively in the Sharon Advocate a newspaper published in said County, said posting and the last publication of said copy having been fourteen days at least before the time appointed for said view, that all persons and corporations interested for or against said petition, might then and there appear and be heard if they saw fit. And on the said second day of June the Commissioners, Edward W. Hunt, Frederick A. Leavitt and Russell T. Bates met at the time and place specified in said order, when and where the petitioners appeared, and the town of Sharon was represented by its Selectmen; and the said Commissioners then viewed the route and premises, and heard all persons and corporations interested; and no party interested objected and thereupon the said Commissioners did adjudge that common convenience and necessity require that said way be relocated as prayed for in said petition. And thence the same was continued and adjourned to a meeting of said Commissioners held at Sharon on the seventh day of July 1931 at two thirty o'clock in the afternoon, when and where the Commissioners heard all owners of property to be taken or affected by these proceedings and thence the same was continued to this meeting. And now the said Commissioners, by courses and distances, metes and bounds do relocate said South Main Street as prayed for in said petition. And the lines of said relocation of said South Main Street are as follows: The northerly line begins at a stone bound in the easterly line of location of the Providence Division of the N.Y., N.H. & H.R.R. said bound bearing N-58-43-E 103.68 ft. from the stone bound at the easterly end of the northerly

line of South Main Street as laid out by the Norfolk County Commissioners by return dated June 3, 1930, thence N-58-40-10-E 528.20 ft. to a stone bound; thence by a 1600.00 ft. radius curve to the left 286.54 ft. to a stone bound; thence N-48-24-30-E 141.30 ft. to a stone bound; thence by a 4060.00 ft. radius curve to the right 346.82 ft. to a stone bound; thence N-53-18-10-E 300.00 ft. to a stone bound; thence by the same course 318.07 ft. to a stone bound; thence by a 2000.00 ft. radius curve to the left 401.96 ft. to a stone bound; thence continuing in the same curve 401.96 ft. to a stone bound; thence N-30-16-20-E 211.96 ft. to a stone bound; thence by a 4700.00 ft. radius curve to the left 494.92 ft. to a stone bound in the present northerly line of South Main Street; thence continuing by a 21.91 ft. radius curve to the left 33.54 ft. to a stone bound in the westerly line of Oakland Street; thence N-24-34-00-E 40.02 ft. across said Oakland Street to a stone bound in the easterly line of said Oakland Street; thence easterly and northerly by a 20.00 ft. radius curve 32.22 ft. to a stone bound in the present northerly line of said South Main Street, as laid out by the Norfolk County Commissioners by return dated April 17, 1894; thence N-24-14-20-E 123.18 ft. in said present northerly line to a stone bound. The southerly line begins at a stone bound in the easterly line of location of said N.Y., N.H. & H.R.R. said bound bearing N-58-43-E 103.62 ft. from the stone bound at the easterly end of the southerly line of South Main Street as laid out by the Norfolk County Commissioners by return dated June 3, 1930, said bound also bearing S-5-58-30-W 75.43 ft. from the point of beginning of the northerly line as above described, thence N-58-40-10-E 594.33 ft. to a stone bound; thence by a 35.00 ft. radius curve to the right 80.14 ft. to a stone bound in the westerly line of East Foxboro Street; thence N-60-59-50-E 64.21 ft. across said East Foxboro Street to a stone bound on the easterly side of said East Foxboro Street; thence northerly and north easterly by a 50.00 ft. radius curve 84.74 ft. to a stone bound on the southerly side of Gun House Street; thence N-24-43-30-E 50.46 ft. across said Gun House Street to a stone bound in the approximate northerly line of said Gun House Street; thence westerly and northerly by a 30.00 ft. radius curve 63.59 ft. to a stone bound; thence N-48-24-30-E 193.02 ft. to a stone bound; thence by a 4000.00 ft. radius curve to the right 341.70 ft. to a stone bound; thence N-53-18-10-E 300.00 ft. to a stone bound; thence by the same course 318.07 ft. to a stone bound; thence by a 2060.00 ft. radius curve to the left 391.10 ft. to a stone bound; thence continuing by a 25.00 ft. radius curve to the right 41.33 ft. to a stone bound in the westerly line of Gertrude Avenue; thence N-33-57-30-E 41.09 ft. across said Gertrude Avenue to a stone bound in the easterly line of said Gertrude Avenue, thence northerly and easterly by a 25.00 ft. radius curve 36.12 ft. to a stone bound; thence by a 2060.00 ft. radius curve to the left 347.50 ft. to a stone bound in the present southerly line of said South Main Street as laid out by the Norfolk County Commissioners by return dated April 17, 1894; thence N-30-16-20-E in said present southerly line 291.92 ft. to a stone bound; thence by a 75.00 ft. radius curve to the right 95.47 ft. to a stone bound in the southerly line of Ames Street; thence N-13-12-20-E 40.00 ft. across said Ames Street to a stone bound in the northerly line of said Ames Street; thence north westerly and northerly by a 35.62 ft. radius curve 62.90 ft. to a stone bound in the southerly line of

South Main Street as established on December 27, 1927; thence N-24-22-50-E 406.27 ft. in said line to a stone bound; thence N-20-20-50-E 43.73 ft. to an iron pin in the present southerly line of South Main Street as laid out by the Norfolk County Commissioners by return dated April 17, 1894; thence N-24-14-20-E 36.15 ft. in said southerly line to a stone bound, said bound bearing S-65-51-40-E 50.00 ft. from the last bound in the northerly line as above described. Said lines are shown on a plan entitled "Plan showing the Relocation and Widening of South Main St., Sharon from the N.Y., N.H. & H.R.R. to Oakland St., as made by the Norfolk County Commissioners by Return dated July 28, 1931, Hartley L. White, County Engineer, Scale 1 inch=40 feet" and marked "Edward W. Hunt" Chairman which plan is filed herewith and made a part of this return. And the said commissioners do hereby take for the purposes of a highway all the easements and rights incident to a public highway in the lands included within the lines of relocation hereinbefore described and as shown on the plan hereinbefore referred to and made a part hereof in so far as such lands may lie outside the limits of said way as heretofore defined. And permanent stone or concrete bounds, not less than three feet long, two feet of which at least shall be inserted in the earth, will be erected at the termini and angles of the way relocated as aforesaid, when practicable; and, when not so, a heap of stones, a living tree, a permanent rock, or the corner of an edifice will be a substitute; or said bounds may be permanent stone or concrete bounds not less than three feet long, with holes drilled therein, and filled with lead, placed a few inches below the travelled part of the street or way. And it is determined that the Inhabitants of the Town of Sharon do within two years from the date of this return and order complete said way in a thorough and workmanlike manner and to the acceptance of the County Commissioners. Said way shall be constructed to the full width indicated on said plan, throughout the entire length of the portion relocated by this return and order. Suitable sidewalks, gutters, culverts, retaining walls, fences, and railings shall be constructed wherever needed. And it is determined by the Commissioners that all the expenses of making the relocation of way as prescribed in this return and order including the expenses of constructing said way, and all land and other damages and expenses incident thereto, be paid by the Inhabitants of the Town of Sharon. And the Commissioners have heard the proprietors of lands and property, rights and interests, taken or affected by these proceedings, and have considered and estimated the damages sustained in the premises, having had regard to all the damages done to the parties respectively, whether by taking their property or injuring it in any manner, and having allowed, by way of set off, the benefits, if any, to the property of said parties in the premises, and do estimate and determine the damages to be paid to said parties respectively, in the sums hereafter named; the same to be paid to said parties respectively by the inhabitants of the town of Sharon when the lands hereby taken and over which said way is hereby located, have been entered upon and possession taken, for the purpose of constructing the said way.
