At a meeting of the County Commissioners of the County of Norfolk, held at Dedham, in said County, on the twenty-third day of October 1934 by adjournment of their Sept. meeting next preceding: Ordered, that the Return and Order of Taking of County Commissioners, dated June 19, 1934, on petition of Peter J. Feeney and others for the extension of Nahatan Street, Norwood, be and the same hereby is amended by inserting in said return after the paragraph reading as follows: "And the said commissioners do likewise further take all the easements in lands adjoining the location of said way as hereby established, consisting of the right to have the lands in said location protected by having the surface of adjoining land slope from the lines of said location as indicated on said plan" the following paragraph: "And the said commissioners do likewise further take the right to have the lands of said location protected by having the surface of adjoining lands slope from the lines of said location within the areas indicated on a plan entitled: "Plan showing areas of adjoining lands subject to easements for protection of location of Nahatan Street in Norwood as established by amendment dated October 23, 1934 to return and order of taking of County Commissioners dated June 19, 1934 and recorded with Norfolk Deeds, Book 2035, Page 16, and Plan Book 118, page 353" which plan is filed herewith and made a part hereof."
