At a meeting of the County Commissioners for the County of Norfolk, held at Dedham, within and for said County, on the second day of June, 1936, by adjournment of their April meeting next preceding: The petition of Earle D.Sullivan and others of Foxborough, in said County, represent as follows: Commonwealth of Massachusetts Norfolk, ss. To the Honorable the County Commissioners of the County of Norfolk: Respectfully represent your petitioners, inhabitants of the town of Foxborough in said County, that common convenience and necessity require that that portion of the way known as Washington Street, a public way in said town between the junction of said way and the New Way leading to Summer Street in Walpole and the southerly line of location of the New York, New Haven & Hartford Railroad Company where said way crosses said railroad be discontinued. Wherefore your petitioners pray that said way may be discontinued within the limits above specified. Dated May 29th, 1936

This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners, held at Dedham aforesaid on the second day of June, 1936, by adjournment of their April meeting next preceding; and the twenty-third day of June then next, and two o'clock in the aforenoon, at the Court House in said Dedham, were appointed by the Commissioners as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said petition, and of this order thereon, to be served upon the Clerk of the Town of Foxborough, being the town within which such discontinuance of way was prayed for, fifteen days at least before the time appointed for said view; and also caused copies of said petition and order to be posted in two public places in said town; and also gave notice to all persons interested, by causing a like copy to be published one week in the Foxborough Reporter, a newspaper published in said county, said posting and publication of said copy having been seven days at least before the time appointed for said view, that all persons and corporations interested for or against said petition, might then and there appear and be heard if they saw fit. And on the said twenty-third day of June, 1936, the Commissioners, Edward W. Hunt, Frederick A. Leavitt, and Russell T. Bates met at the time and place specified in said order, when and where Hartley L. White appeared and explained the purpose

of the petition; and no party interested objected;	when and where the said Commissioners pro-
ceeded to consider and adjudicate upon the prayer	of said petition, and thereupon the said
Commissioners did adjudge that common convenience	and necessity require that said way be
discontinued as prayed for in said petition.	And now the said Commissioners, by
courses and distances metes and bounds, do discont	inue that portion of Washington Street in
Foxborough as prayed for in said petition. And the lines of said discontinuance of said Wasa-	
ington Street are as follows: Beginning at a stone bound at the Westerly end of the curve	
at the northerly corner of a New Way and Washington Street as laid out by the Norfolk Coun-	
ty Commissioners by return dated November 21,1933, thence southerly, easterly, and north east-	
erly by a 20.00 ft radius curve 52.20 ft.to a point in the northerly line of said Washing-	
ton Street; thence N.27-04-00 E 275.00 ft.in said northerly line to an unmarked point in the	
westerly line of location of the New York, New Haven & Hartford Railroad Co.; thence S 00-50-	
00 E 149.60 ft.in said westerly line of location to an unmarked point in the southerly line	
of said Washington Street; thence S 27-04-00 W 335.43 ft.in said southerly line of Washing-	
ton Street to a stone bound; thence N 3-22-30 W 211.67 ft.to the stone bound at the point
