At a meeting of the County Commissioners for the County of Norfolk, held at Dedham, within and for said County on the seventeenth day of September, 1968, a notice of said meeting having been posted as required by law:

The petition of John A. Abdallah and others of Norwood in said County, represents as follows:

Commonwealth of Massachusetts,

Norfolk, ss.

To the Honorable the County Commissioners of the County of Norfolk:

Respectfully represent your petitioners, inhabitants of the town of Norwood in said County, that common convenience and necessity require that a portion of the way known as NANATAN Street, a public way in said town, be discontinued at the Blue Star Memorial Highway, Route #1, being that portion laid out by the Norfolk County Commissioners December 1, 1942, which was not occupied for the construction of the overpass by the Massachusetts Department of Public Works taking of October 9, 1956.

Wherefore your petitioners pray that said way may be discontinued within the limits above specified.

This petition was presented to the Commissioners and duly entered at a meeting of said Commissioners, held at Dedham, on the twentieth day of February, 1968 by adjournment of their December meeting next preceding; a notice of said meeting having been posted as required by law; and the nineteenth day of March, 1968, and two-thirty o'clock in the afternoon at the Court House in said Dedham were appointed as the time and place for commencing and proceeding to view the premises; and they thereupon caused a copy of said petition, and of order of notice thereon, to be served upon the Clerk of the Town of Norwood, being the town within which such discontinuance was prayed for, fifteen days at

least before the time appointed for said view; and also caused 389
copies of an abstract of said petition and of said order of
notice to be posted in two public places in said town; and to be
published in the Norwood Messenger, a newspaper published in said
County, said posting and publication having been seven days at
least before the time appointed for said view, that all persons
and corporations interested for or against said petition, might
then and there appear and be heard if they saw fit.

And on the nineteenth day of March, 1968, the Commis-
sioners, upon a request of the Board of Selectmen of the Town
of Norwood voted to continue said hearing to Tuesday, March 26,
1968, at three-thirty o'clock in the afternoon at the Court
House in said Dedham.

And on the twenty-sixth day of March, 1968, the Commis-
sioners, James J. Collins and Russell T. Bates met at the time
and place specified, when and where the petitioners appeared,
and the Town of Norwood was represented by its Selectmen; and
the said Commissioners then viewed the route and premises, and
heard all persons and corporations interested; and no party
interested objected; and thereupon the said Commissioners did ad-
judge that common convenience and necessity require that said
way be discontinued as prayed for in said petition.

And thence the same was continued and adjourned from
time to time to this meeting.

And now the said Commissioners do hereby discontinue
two portions of Nahatan Street between West Border Road and
Neponset Street.

And the lines and portions of said discontinuance of
said Nahatan Street are as follows:

PARCEL I. Beginning at the northerly end of Parcel
I at a point on the southerly line of the Blue Star Memorial
Highway as laid out by the Massachusetts Department of Public
Works October 9, 1956; thence easterly, southeasterly and

southerly by the line of said Blue Star Memorial Highway a distance of 96¹/₂ feet, 161.01 feet and 360²/₂ feet respectively; thence northwesterly and northerly by the southerly line of Nahatan Street as laid out by the Norfolk County Commissioners by return dated December 1, 1942, a distance of 141²/₂ feet, 115.00 feet, 175.00 feet and 170²/₂ feet respectively to the point of beginning.

PARCEL II. Beginning at the southwesterly end of Parcel II at a point on the easterly line of the Blue Star Memorial Highway as above described; thence northerly, northeasterly and easterly by the line of said Blue Star Memorial Highway 324.36 feet, 111.41 feet and 86²/₂ feet respectively; thence southerly and south-easterly by the northerly line of Nahatan Street as laid out by the Norfolk County Commissioners by Return dated December 1, 1942 a distance of 134²/₂ feet and 226²/₂ feet respectively; thence S-17-17-00 E a distance of 351.94 feet to a point on the southerly line of Nahatan Street as above described; thence northwesterly by a curve to the left with a radius of 845.83 feet a distance of 71.36 feet by the southerly line of said Nahatan Street; thence continuing northwesterly by the Southerly line of said Nahatan Street by a curve to the left with a radius of 1210.00 feet a distance of 431.29 feet; thence westerly by the southerly line of said Nahatan Street a distance of 235.00 feet and 105²/₂ feet respectively to the point of beginning.

And it is determined by the Commissioners that all lands within the lines of parcels 1 and 2 above described are hereby discontinued as a Highway.

Said lines and parcels are shown upon a plan entitled "Plan showing the discontinuance as a highway of portions of Nahatan Street, Norwood, between West Border Road and Neponset Street as made by the Norfolk County Commissioners by Return dated September 17, 1968. Scale: 1 inch = 40 ft. Charles C. Cain, County Engineer" and signed by "James J. Collins, Chairman"
