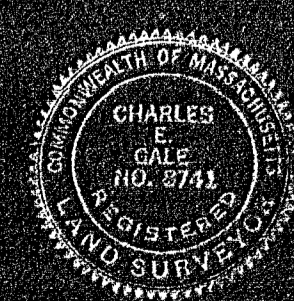


PLAN OF LAND IN BRAINTREE & WEYMOUTH, NORFOLK CO, MASS

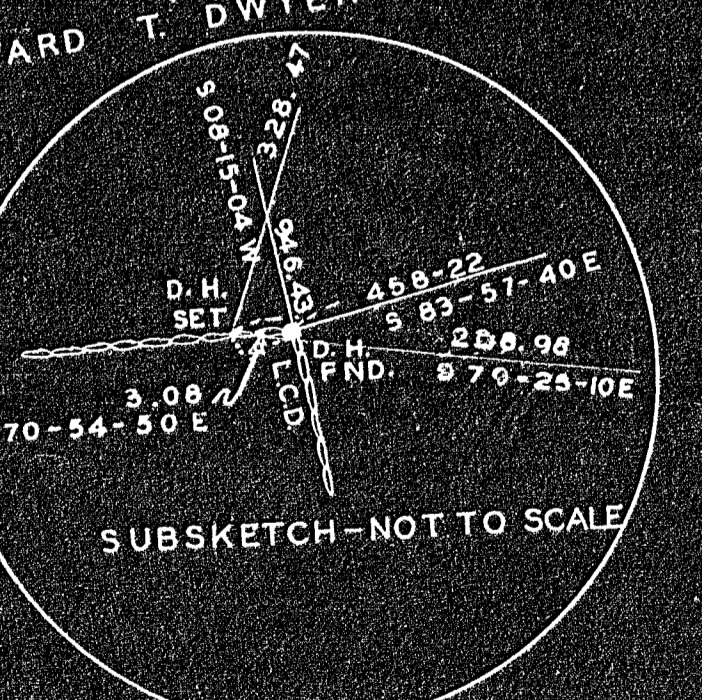
