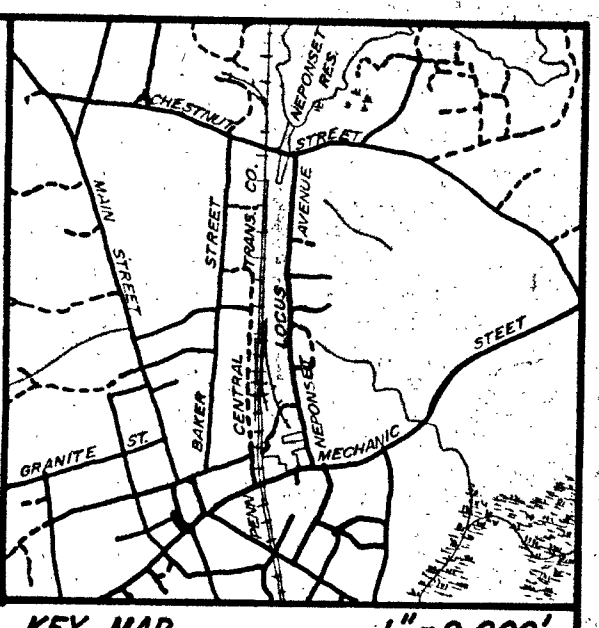

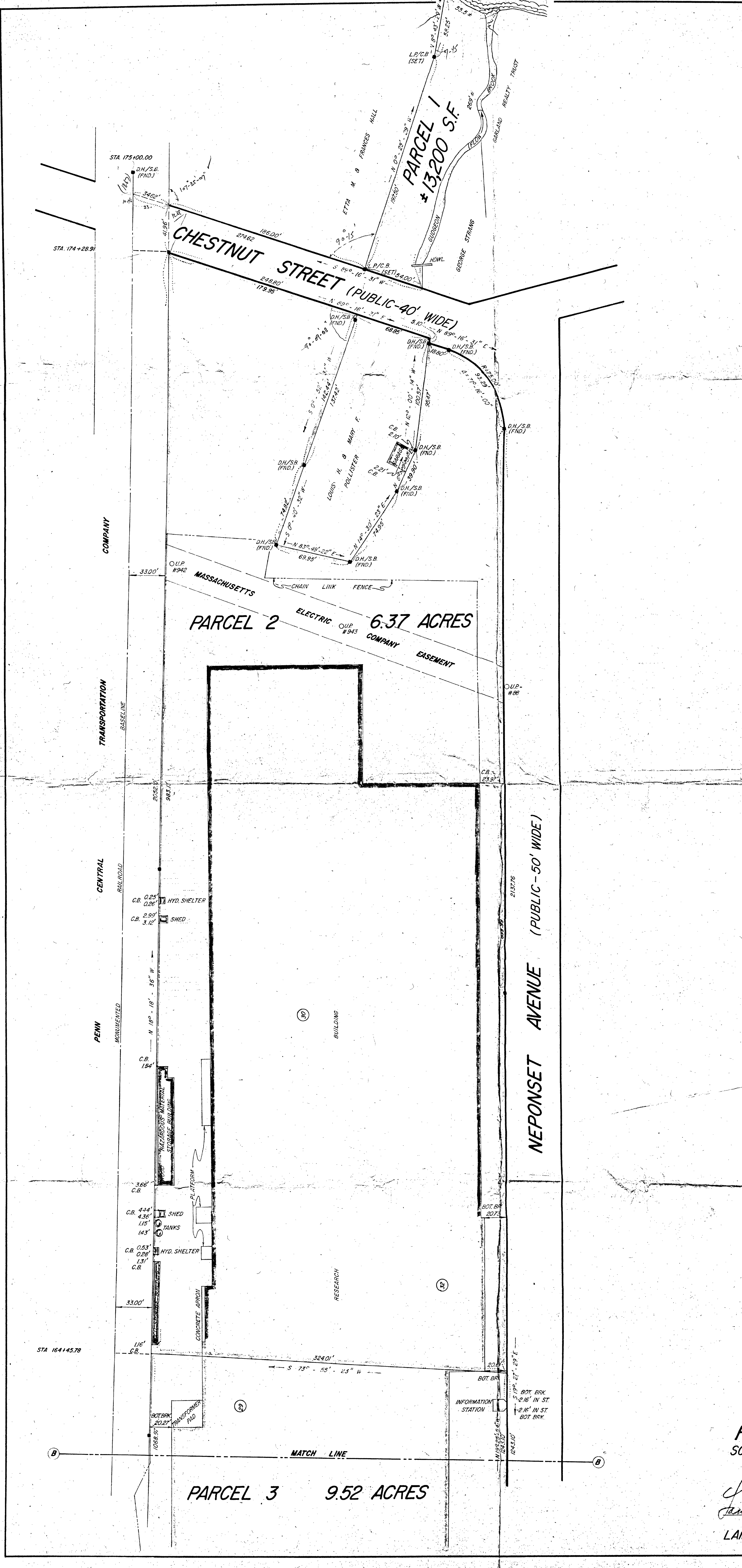

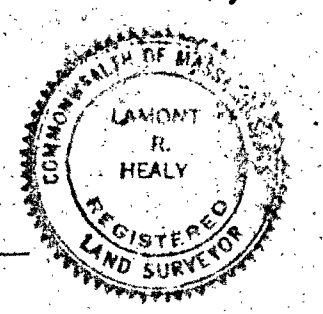


PLAN OF LAND IN
FOXBOROUGH, MASS.

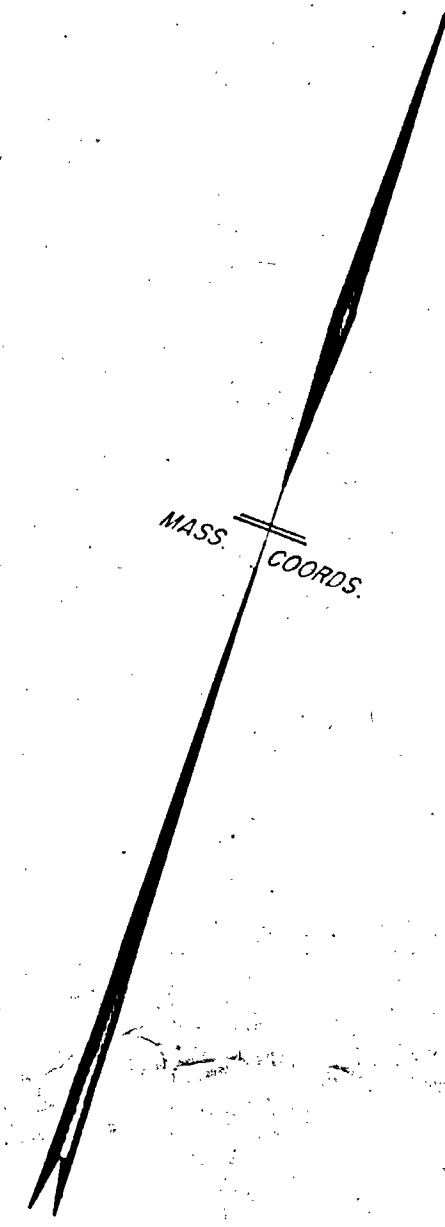
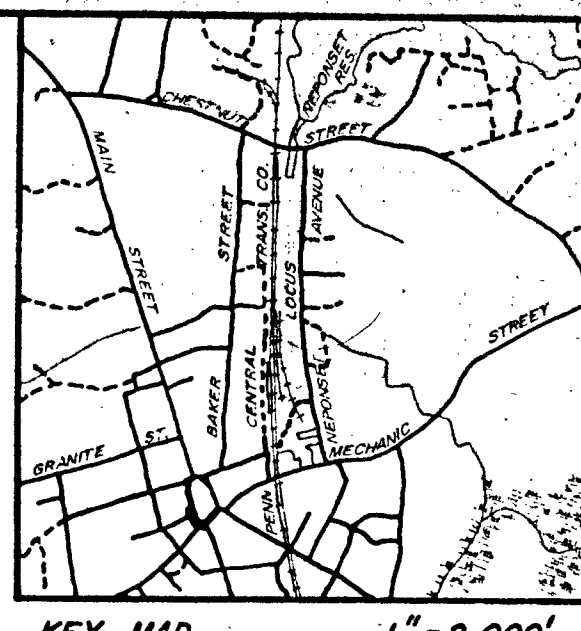
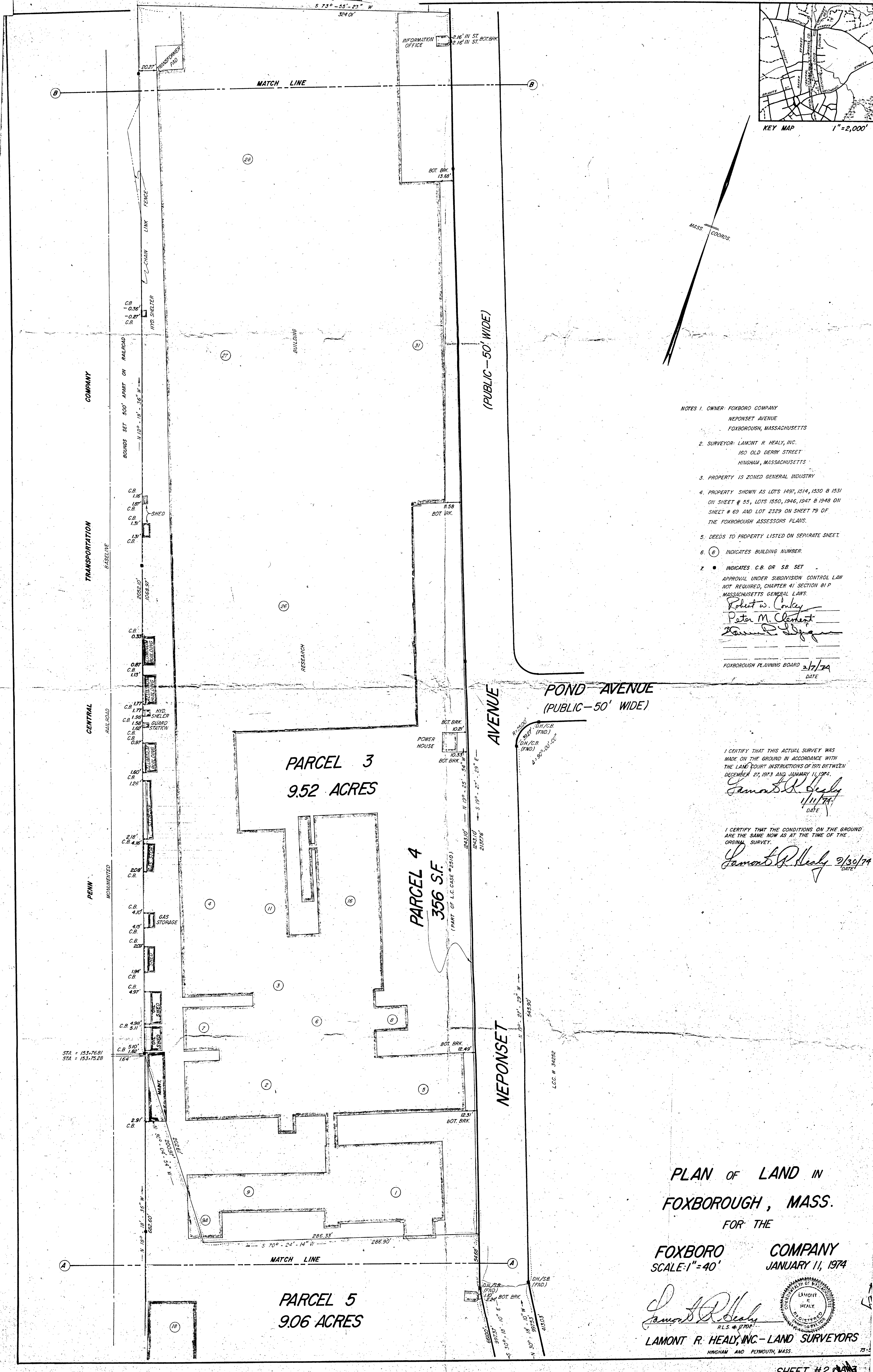

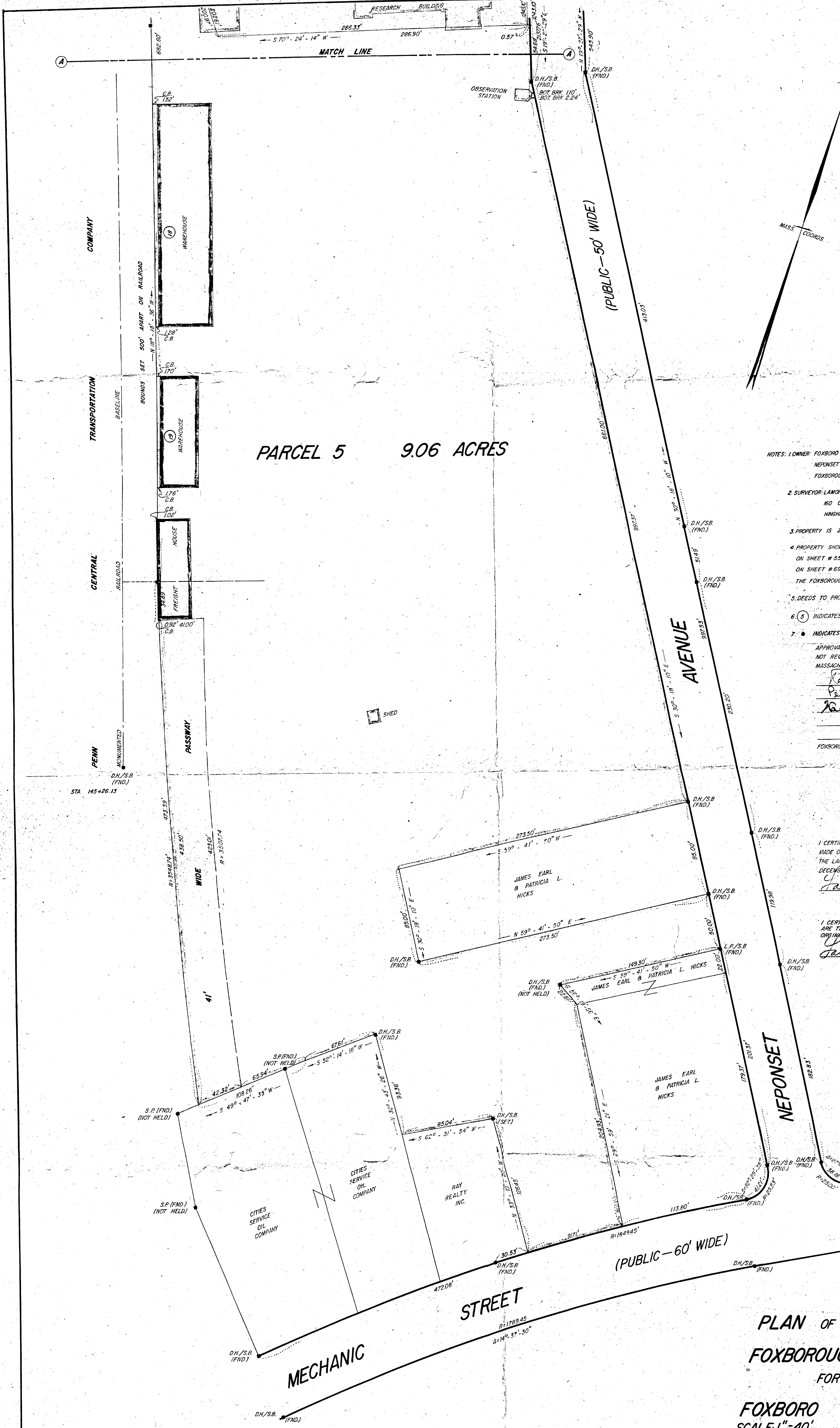
