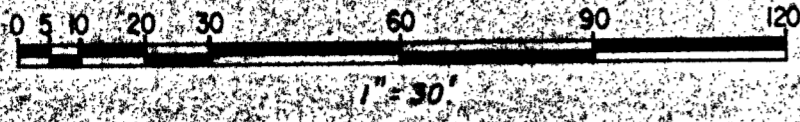


PLAN OF LAND IN
